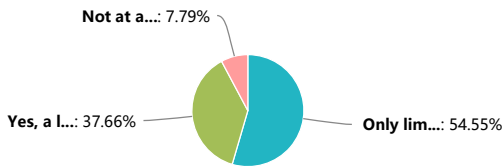

Q1:Is your company affected by the economic slowdown...(单选题)

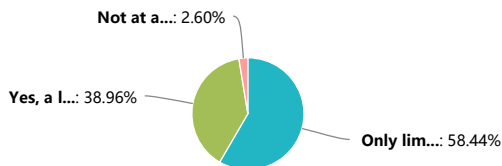

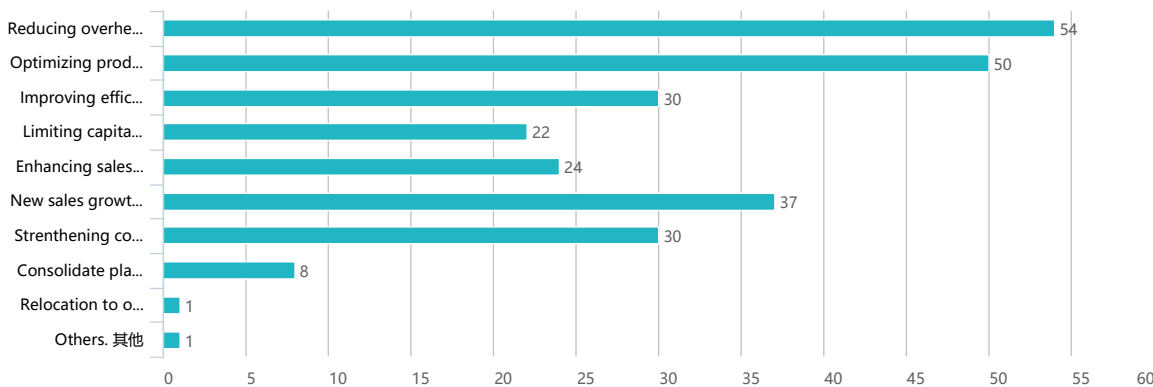

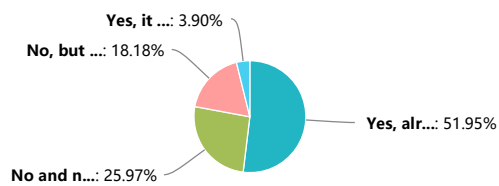

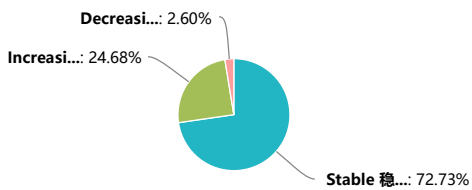

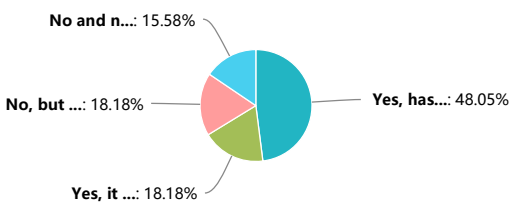

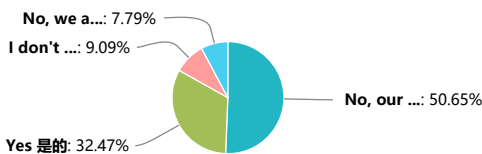

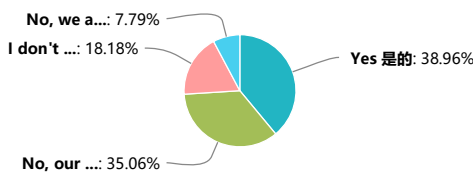
