On March 22nd, 2018 afternoon, more than 60 financial & controlling managers and professionals coming from Sino-German business community attended a workshop focusing on the topic "Project Controlling in Practice" in the Training Center Taicang of Schaeffler Academy Greater China.

The first speaker was Mr. Tao ZOU, Head of Industrial Controlling at Schaeffler Greater China. He presented relevant methodological concepts used by Schaeffler for project planning and project tracking.

Based on long-year experience in the field of project management and controlling as well as strong SAP system support, Schaeffler has developed a comprehensive system for

project profitability analysis prior to a project decision and for project review and detailed plan-actual deviation analysis during the phase of project implementation. As a member of the project team, controller uses the system to collect, calculate and analyze all relevant data of the project provided by non-financial departments involved in the project. Both business / technological understanding and good communication skills are important for successful project controlling work.

The second VIP presentation was provided by Mr. Oliver DIEHM, Head of Controlling China and Acting CFO of Brose China, and his Chinese colleague Mr. Haiqing HUANG, Head of Project Controlling of the Door System Division at Brose China. Brose is a family-owned large business group with specific business model and organizational characteristics. In China, Brose has a relatively large team of project controllers many of whom have technological or non-finance background. Managing many different long-lasting projects and taking the entire life cycle of all projects as subject of controlling, Brose put emphasis on strong integration of project controlling and the remaining parts of its controlling systems, such as plant controlling and long-term business planning. In the view of Brose, a successful project controller should develop his/her competences continuously and change his/her role and mindset from Calculator through Analyzer to Navigator.

The third VIP speaker was Mr. Michael Ellenrieder, General Manager of Werma (Shanghai) Co., Ltd. Werma is a small German family-owned company with competitive position in its specific niche market. Like many other German small-to-medium sized businesses, Werman has developed its own simple but effective way for project management and controlling. Mr. Ellenrieder showed the opportunities and risks of project management and controlling in China and shared experience and lessons learnt of the company in regards of market specification, time-to-market, quality and cost of the projects. He also pointed out that lack of qualified controllers and limited IT resources remain challenges especially small-to-medium sized companies have to deal with.
